- 1. This "Certificate of Participation Owner" (hereinafter referred to as "this Certificate") hereby certifies that the Owner(s) stated in this Certificate is/are permitted to participate in the Hong Kong Housing Society (hereinafter referred to as "HS") T-Home "Letting Scheme for Subsidised Sale Developments with Premium Unpaid" (hereinafter referred to as "the Scheme").

- 2. Subject to the terms and conditions stated in the "Declaration and Undertaking" signed by the above Owner(s), and subject to the terms and conditions of the Scheme, in accepting and abiding by the aforementioned terms and conditions, the above Owner(s) may let the above Flat/bedroom(s) thereof to (i) person holding a valid "Certificate of Participation Tenant" issued by HS under the Scheme and valid "Nomination Certificate" issued by the Hong Kong Housing Authority (hereinafter referred to as "HA") in respect of the above Flat at the same time (hereinafter referred to as "HKCSS") holding a valid "Certificate of Participation Organisation" issued by HS under the Scheme and valid "Nomination Certificate" issued by HA in respect of the above Flat at the same time in accordance with the following situations:

上述業主於接受及遵守其所簽署的「聲明及承諾書」上所列條款及條件下及按照本計劃既定條款及條件下,可將上述單位/其睡房按以下情況出租予(i)同時持有由房協發出本計劃有效「參與計劃證明書 - 租客」及由香港房屋委員會(下稱"房委會")就上述單位發出有效「提名證書」的人士(下稱"指定人士"),或(ii)同時持有由房協發出本計劃有效「參與計劃證明書 - 機構」及由房委會就上述單位發出有效「提名證書」的香港社會服務聯會(下稱"社聯"):

- 2.1 Let one or more bedroom(s) of the Flat to at most two Specified Persons, and each Specified Person must at least rent one bedroom; or

- 2.2 Let the entire Flat to one Specified Person; or 將整個單位出租予一名指定人士;或

3. The relevant "Certificate of Participation – Owner", "Certificate of Participation – Organisation"/"Certificate of Participation – Tenant" and HA's "Nomination Certificate" must remain valid as at the date of signing of the tenancy agreement (or renewing of the tenancy agreement). Both parties must use the prescribed tenancy agreement of the Scheme.

- 4. The expiration date of the tenancy agreement shall not exceed 31 October 2026. 租約生效期屆滿日不得超越 2026 年 10 月 31 日。
- 5. After the signing or renewing of the tenancy agreement, the holder of this Certificate and the Tenant shall each complete and sign the "Notice of Execution of the Tenancy Agreement" prepared by HS, and within 2 weeks submit online or post the said notice to Hong Kong Housing Society Applications Section. Please indicate "Letting Scheme for Subsidised Sale Developments with Premium Unpaid" and the application number on the cover of the envelope.
