Notice of Early Termination of the Tenancy Agreement
(For Holder of “Certificate of Participation - Tenant”)

(Tenant should return the duly completed “Notice of Early Termination of the Tenancy Agreement” to Applications Section of Hong Kong Housing Society within **2 weeks** from the date of **serving or receiving** a written notice for early termination of tenancy agreement^(Note 1))

To: Hong Kong Housing Society (“HS”) :

1. I confirm I have early terminated the tenancy agreement with the owner(s) holding a valid “Certificate of Participation – Owner”. Please refer to the relevant particulars on the back page.
2. I hereby confirm the information stated on the back page is true and correct.
3. I acknowledge and agree that HS will provide the information of the relevant tenancy agreement to the public for reference. For instance,
 - The commencement date of the tenancy agreement;
 - The original tenancy agreement expiry date;
 - The date of termination of the tenancy agreement;
 - The housing estate;
 - Floor (e.g. high/middle/low floor); and
 - Rented area (e.g. entire flat, one bedroom or two bedrooms).

Notes on Collection of Personal Data

1. The personal data provided in the “Notice of Early Termination of the Tenancy Agreement” (“the Notice”) is only used for HS’s internal record. HS may also use the information for statistical surveys or researches, and may for such purpose contact the tenant.
2. HS has the right to compare and match the personal data provided in the Notice with the relevant personal data collected for other purposes (manually or otherwise) in order to ascertain whether such information is false or inaccurate or misleading.
3. Pursuant to the Personal Data (Privacy) Ordinance (Cap. 486), the tenant is entitled to request access to or correction of the personal data stated in the Notice relating to him. Where necessary, such requests should be directed by post to the General Manager (Property Management), Applications Section of Hong Kong Housing Society, at the G/F, Dragon Centre, 23 Wun Sha Street, Tai Hang, Hong Kong. A fee may be charged for the request for access to personal data and/or to obtain a copy of personal data.

Note 1: The Notice can be filled in and submitted immediately at the “Owner and Tenant Information Sharing Platform” after login, or can also be downloaded at the designated website of the Scheme: lettingscheme.hkhs.com, or collected at the HS Applications Section (address: G/F, Dragon Centre, 23 Wun Sha Street, Tai Hang, Hong Kong).
